CORE OBJECTIVE

Providing de-risked opportunities for all adult Africans to participate and earn money from Agriculture and Agribusiness under 48 well-defined stakeholder categories. Subject to necessary periodic reviews, each Stakeholder category has its engagement terms and conditions clearly defined, written and documented.

IMPLEMENTATION

The Programme is designed to be implemented by Adasomi Development Company Limited (ADCL) and other members of Adasomi and Revacom Consortium in the whole of Africa through a Franchising Model that entails the appointment of one Franchise Company for each Country, one Sub-Franchise Company for each State/Region within the country and one Franchise Cooperative Society for each Community within any given State or Region.

- To Provide Access to Land, Technical Expertise, Finance and Market for Stakeholders interested in farming and food processing.
- To Provide end to end solutions for all types of Transactions within the Agriculture and Agribusiness Value Chain.
- To provide access to Technical Expertise, Finance, Market and Fair Pricing for Rural Farmers
- To provide Sustainable revenue to Land Owners, Participating Communities, Local Government Councils and State Governments.
- To provide Additional revenue to Land Owners, Participating Communities,Local Government Councils and State Governments Through the Voluntary Carbon Market.
- To provide practical and sustainable community based security solution for farming in rural areas.
- To promote financial inclusion and poverty reduction through Agriculture and Agribusiness.
- To promote sustainable Agriculture and food security in Africa.
- To promote environmental protection, community policing and crime reduction through Agriculture and Agribusiness.
- To promote the reduction of rural urban migration induced by unemployment and lack of opportunities in rural areas

1	Adasomi Farm Estate Scheme	Conceptualized and designed for fastracking the development of Farm Estates on behalf of Proxy Farmers, for farming and production of produce especially in satisfaction of industrial off-takers and big commodity dealers.
2	Adasomi Out- growers Scheme	Designed to incorporate existing farms and out-growers into the Programme by providing them desired access to technical expertise, market, finance, and fair pricing for their produce. Leveraging the Adasomi Cluster Farming system, prequalified individuals are trained as Farmers or Food processors and allocated spaces within Hectare by Hectare Farming Clusters and given access to technical support, finance and market.

4	Adasomi Premium Discount Scheme	Conceptualized and developed mainly to promote the marketing and distribution of farm produce and food processed under the Programme directly to homes of participating consumers and Food Processors at below market price across the African continent; and the entire world .
5	Hectare by Hectare Volunteering Scheme	This was conceptualized and designed for delivering the social content of the Programme. As compensation for the access to Economic Empowerment granted to them, Farm To Home Agents with the aid of learning materials developed under the Programme, are required to Act as Awareness Volunteers and Change Agents and carry out Community Volunteering Services such as Road Maintenance, Maintenance of Common Community Assets, Agricultural Extension Services, Environmental Protection and Community Policing. In furtherance of our Corporate Policy that for every tree removed towards the development of any Farm Estate, two other trees must be planted, these Farm To Home Agents are required to engage in planting of Economic Trees on available spaces within their Communities, thereby enhancing their potential to earn additional income from the voluntary carbon market. In collaboration with Lawquest, strategic stakeholders and other members of Adasomi and Revacom Consortium, Adasomi Foundation handles the day to day management of the Hectare by Hectare Volunteering Scheme.

Farms are developed in schools thereby providing more food, extra income to staff, revenue to the participating schools and practical learning experience for the students.

Several REVACOM Food Courts are developed in Urban areas to stimulate and create more opportunities for organized off-take of food and agricultural raw materials farmed and processed within the Hectare by Hectare value chain. REVACOM Food Courts are also established in Tertiary Institutions across Africa, thereby enabling the supply of affordable food to students and providing opportunities for extra income for staff of the institutions. In this regard, existing refectories are also refurbished and converted to REVACOM food Courts.

Opportunities are created for all adult Africans to invest as Value Partners to own fractional interest in REVACOM Food Courts and earn daily income from food and beverages sold at the Food Courts.

Small and Medium Income Food Vendors are without any upfront payment of rent allocated fully equipped kitchens to operate in REVACOM Food Courts.

Food is supplied directly from farmers, Out-growers and Food Processors through local Sub-consolidators at below market price to homes of participating consumers within Africa. Massive inflow of foreign exchange is achieved through direct supply of farm produce and processed food to Africans living in the diaspora through Diaspora Sub-consolidators.

Farm To Home Agents (mostly unemployed youths) are continuously empowered through the award of Premium Discount Supply & Forward Contracts created under the entire Programme for supply and off-take of inputs, machineries, farm produce and processed food.

As compensation for access to economic empowerment granted to them, Farm To Home Agents through the Hectare By Hectare Volunteering Scheme managed by Adasomi Foundation (ADF) provide Volunteering Services in their respective communities. The number of contract lots secured by each Farm To Home Agent is determined by the level of voluntary community services rendered by his/her Farm To Home Cooperative Society.



LOGISTICS SUPPORT FOR THE PROGRAMME

Hectare By Hectare is an enterprise of significant proportion and the logistics services of the entire Programme is exclusively reserved and managed by Adasomi Logistics Limited, a wholly owned subsidiary of ADCL. The value added chain being created under the 5(five) schemes of the Hectare By Hectare Programme needs unlocking through e-commerce and reliable last-mile delivery solutions which the Adasomi Logistics System was designed to provide. The full activation of Adasomi Logistics Services with all its Software Applications will catalyse the full implementation of the Hectare By Hectare Programme which will in turn create opportunities for Adasomi Logistics Limited to attain its full and desired potential. The framework of Adasomi Logistics Limited is a scalable asset-light structure with its technology platform supporting; Transport & distribution, Warehousing, Supply Chain Management, and Customer Relations Management. The use of Sub-consolidators and Solar Powered Tri-cycles for last-mile deliveries within each established cluster achieves remarkable reduction in cost of logistics.
